STRUCTURE OF OCCUPATION CODE LIST

The Occupational Code list is the list of occupations with their codes used to code occupations described in P14 of the Census questionnaire In the code list, Occupations are first classified into 10 major groups 0-9 (1 **digit**) as follows:

Major Group 1	Managers
Major Group 2	Professionals
Major Group 3	Technicians and associate professionals
Major Group 4	Clerical support workers
Major Group 5	Service and Sales workers
Major Group 6	Skilled agricultural forestry and fishery workers
Major Group 7	Craft and related trades workers
Major Group 8	Plant and Machine operators and assembles
Major Group 9	Elementary occupations
Major Group 0	Armed Forces occupations

A. Major Group 1 - Managers

Managers plan, direct, coordinate and evaluate the overall activities of enterprises, governments and other organizations, or of organizational units within them and formulate and review their policies, laws, rules and regulations.

Occupation in this Group 1 is divided into 4 sub-major groups as follows;

Sub-major group

- 11 Chief executives, senior officials and legislators
- 12 Administrative and commercial managers
- 13 Production and specialized service managers
- 14 Hospitality, retail and other managers

B. Major Group 2 - Professionals

Professionals increase the existing stock of knowledge, apply scientific or artistic concepts and theories, teach about the foregoing in a systematic manner, or engage in any combination of these activities.

The Professional group is divided into 6 sub-major groups as follows;

- 21 Science and Engineering professionals
- 22 Health professionals
- 23 Teaching professional
- 24 Business and administration professionals
- 25 Information and ICT professionals
- 26 Legal social and cultural professionals

C. Major Group 3 - Technicians and Associate professional

Technicians and associate professionals perform mostly technical and related tasks connected with research and the application of scientific or artistic concepts and operational methods and government or business regulations. These tasks are performed under the supervision of Professionals. Major group 3 is divided into 5 major groups as follows;

- 31 Science and engineering associate professionals
- 32 Health associate professionals
- 33 Business Administration associate professionals
- 34 Legal, social and cultural associate professional
- 35 Information and ICT technicians

D. Major Group 4 - Clerical Support

Clerical support workers record, organize, store, compute and retrieve information related and perform a number of clerical duties in connection with money-handling operations, travel arrangements, requests for information and appointments.

Tasks performed by clerical support workers usually include;

- Stenography
- typing and operating word processors and other office machines;
- entering data into computers; carrying out secretarial duties;

Major Group 4 is divided into 4 sub-major groups as follows;

- 41 General and Keyboard clerks
- 42 Customer service clerks
- 43 Numerical and material recording clerks
- 44 Other clerical support

E. Major Group 5 - Service and sales workers

Service and sales workers provide personal and protective services related to travel, housekeeping, catering, personal care, or protective against fire and unlawful acts, or demonstrate and sell goods in wholesale or retail shops and establishments as well as at stalls and in markets.

Tasks performed by service and sales workers usually include;

Occupations in Major group 5 are classified into 4 sub-major groups as follows;

- 51 Personal service workers
- 52 Sales workers
- 53 Personal care workers
- 54 Protective service workers

F. Major Group 6 - Skilled Agricultural, Forestry and Fishery workers

Skilled agricultural, forestry and fishery workers grow and harvest field or tree and shrub crops, gather wild fruits and plants, breed, tend or hunt animals, produce a variety of animal husbandry products, cultivate, conserve and exploit forests, breed or catch fish and cultivate or gather other forms of aquatic life in order to provide food, shelter and income for themselves and their households.

This major group is divided into the following sub-major groups;

- 61 Market oriented skilled agricultural workers
- 62 Market oriented forestry, fishery and hunting workers
- 63 Subsistence farmers, fishers, hunters and gatherers

G. Major Group 7 - Craft and Related trades workers

Craft and related trades workers apply specific technical and practical knowledge and skills in the fields to construct and maintain buildings, form metal, erect metal structures, set machine tools or make ,fit, maintain and repair machinery, equipment or tools, carry out printing work and to produce or process foodstuffs, textiles, or wooden, metal and other articles, including handicraft goods.

The work is carried out by hand and hand-powered and other tools which are used to reduce the amount of physical effort and time required for specific tasks, as well as to improve the quality of the products. This major group is divided into sub-major groups as follows;

- 71 Building and Related trades workers excluding electricians
- 72 Metal, machinery and related trades workers

- 73 Handicraft and printing workers
- 74 Electrical and Electronic trade workers
- Food, processing, woodworking, garment and other craft and related workers

H. Major Group 8 - Plant and Machine operators and assemblers

Plant and machine operators and assemblers operate and monitor industrial and agricultural machinery and equipment on the spot or by remote control derive and operate trains motor vehicles and mobile machinery and equipment or assemble products from component parts according to strict specifications and procedures. This major group is divided into 3 sub-major groups as follows;

- 81 Stationary plant and machine operators
- 82 Assemblers
- 83 Drivers and mobile plant operators

I. Major Group 9 - Elementary Occupations

Elementary occupations involve the performance of simple and routine tasks which may require the use of hand – held tools and considerable physical effort.

Major group 9 is divided into the following sub-major groups;

- 91 Cleaners and helpers
- 92 Agricultural, forestry and fishing labourers
- 93 Labourers in mining, construction, manufacturing and transport
- 94 Food preparation assistants
- 95 Street and related sales and service workers
- 96 Refuse workers and other elementary workers

J. Major Group 0 - Armed forces occupations

Armed forces occupations include all jobs held by members of the armed forces. Members of the armed forces are those personnel who are currently serving in the armed forces, including auxiliary services, whether on a voluntary or compulsory basis, and who are not free to accept civilian employment and are subject to military discipline. Included are regular members of the army, navy, air force and other military services, as well as conscripts enrolled for military training or other service for a specific period.

Major Group is divided into 3 sub-major groups;

- 01 Commissioned armed forces
- 02 Non-commissioned armed forces
- 03 Armed forces occupations, other ranks

In all there are 43 sub-major groups. Each sub-major group is sub-divided into minor groups (3 digits). The minor groups are each divided into units groups (4 digits). In the 2010 Population and Housing Census coding of both the occupation and industrial activity will be done at the four digit level i.e. at the unit level. This is why we require detailed description of both the Occupation (**P14**) and Industrial activity (**P15c**).

2. <u>How to locate the appropriate occupational code.</u>

The first procedure for finding the occupational code is to ascertain the major group (1digit) to which it belongs. You should then identify the sub major group (2 digit). The next step is to look for the appropriate minor group under that sub- major group. Finally look for the unit group for that occupation from the minor groups. The titles of the various groups (ie.major, sub-major, minor, and unit) usually act as a guide to the appropriate code. However it is not always that you can find the exact occupation that you are looking for. For example you may be looking for Maize Plantation Manager but you only find Plantation Manager. Coding Maize Plantation Manager **1311** is your best option.

In assigning occupational codes, you should also in most cases relate it to the level of education and age of respondent. It is most unlikely to have a medical specialist who has never been to school, or a trained secondary school teacher aged 15 years.

Before proceeding further, certain sections of the coding system should be explained to help you provide appropriate codes.

The Occupational code list at the Minor group level (3 digit) is attached to assist you locate the correct code at that level (see Appendix I).

Explanations

In the Enumerators manual in **Chapter 12** section **P14** Enumerators have been instructed to provide detailed description of occupation (i.e. work done in the 7 days preceding Census Night by respondents. They have also been asked to **avoid vague answers like civil servant**, **businessman, manager, labourer, National Service Personnel, Zoomlion worker, driver, market woman, etc.** As explained in the manual these designations cover several groups of persons doing different kinds of work. You should therefore ask Enumerators to probe further to obtain more specific information on occupation. For some other occupations a little more detail will enable you to assign the correct codes. Teachers for example teach in different levels of educational institutions. We would therefore like to know whether they are;

You can see from the above teaching occupations and their codes that each group of teachers has a different code. This means that if the necessary detail is not provided it will be difficult to assign the correct code. If the correct detail is provided and you do not assign the right code then you are corrupting the data.

b. The Police

Among the Police too, the Enumerator should provide the rank of the respondent. This is because different ranks are coded under different major groups. For example:

c. Armed Forces

Even though for the Armed Forces the various groups are all under one major group. It would be most helpful (as we are using the 4 digits code) if the ranks are provided so that the correct codes could be assigned. Thus, the Enumerator should provide information on the ranks of the following;

Assigning Occupational Codes for persons who engage in the sale of food and other items on the streets can sometimes be problematic. The explanation below can assist coders to assign the correct codes.

"Vendors from street and market stalls of fresh food products not intended for immediate consumption (such as fruit, vegetables, meat and dairy products) are classified in Unit group **5211**, Stall and market salespersons. Vendors from street and market stalls of a variety of prepared meals and food items for immediate consumption are classified in Unit **5246**, Food service counter attendants.

Vendors in streets and public places of food and beverages for immediate consumption from pushcarts, trucks, trays or baskets are classified in Unit group 5212, Street food salespersons. Vendors in streets and public places of non-food items (or of pre-packaged non-perishable food

items such as confectionery) from pushcarts, trucks, trays or baskets are classified in Unit group **9520**, Street vendors (excluding food)" (ILO, ISCO 2008).

d. Repairers

Another group of occupations which are classified under several minor groups is Repairers. Repairers have been classified under several minor groups. 74(741 and 747, 712) 71, 72, 73, 74 72(723, 722) 73(731).

Coding industrial Activity

The structure of the code list for industrial activity is slightly different from that of the occupational code list. Industrial activity codes are first classified into sections, each group designated by an Alphabets **A-U** as shown below. Each section is then sub-divided into division each designated by 2 digits.

Each division is then subdivided into groups at the 3-digit level as follows;

Each group is then classified into classes at the 4-digit level.

The Industrial code list at the Section, Division, and Group level is attached to assist you locate the correct code (see Appendix II).

As already stated coding of product or service of establishment (industrial activity-P15c) will be at the 4 digit level i.e. at the class level. This means the Enumerators should provide detailed description of industrial activity so that supervisors can code without problems. To code product or service rendered by the establishment. You should first establish the section and division of the product or service. Then you should find the group and finally the class. You should relate the industrial activity to occupation. You can never have a secondary teacher with banking services as industrial activity.

Certain areas in the structure should be explained further to assist the supervisor when coding.

Repair and maintenance

For repair and maintenance provision has not been made for any single category to cover all repair and maintenance activities. The classification is rather based on the type of goods repaired. Thus, we have the following;

Division 33 i.e., <u>repair and installation of machinery and equipment</u> covers repair of various machinery and equipment used in industries.

a) Human Health Activities

In the same way, more detailed description of service offered is required for those employed by health institutions i.e. hospitals, clinics, etc. You should differentiate between services offered in health facilities which have both **inpatient and out-patient facilities** and those which offer **only out-patient facilities**. For health institutions like Korle-Bu Teaching Hospital, Ridge Hospital, Kaneshie Polyclinic, Komfo Anokye Teaching Hospital which have inpatient and out-patient facilities, main service will be "Hospital Activities" code 8610. For those clinics which have only out-patient facilities, the main service is Medical and Dental activities 8620

b) Insurance

You should also make a clear distinction between respondents who work in insurance companies which deal with <u>life insurance</u> only and those who cover **non-life insurance** e.g. marine, fire, aviation, property, health, etc.



c) Wholesale Trade

In wholesale trade, distinction should be made between trading in <u>specialised</u> and <u>non-specialised</u> goods. This means dealing in one type of goods e.g. textile clothing and footwear; electronic and telecommunication equipment and parts or dealing in a variety of goods without any particular specialisation.

The diagram below will assist you finding the right code.



d) Retail Trade

Similarly, for Retail trade, distinction is required first by type of sale outlet i.e. retail trade in stores and retail trade not in stores. For retail trade in stores, further distinction is required between specialised i.e. range of items sold and non-specialised retail trade.

Retail trade not-in-stores is classified by place where goods are sold e.g. <u>retail</u> <u>sale in stalls and markets</u>, door to door, mail order, by vending machines, on the street, in front of houses, etc.

The diagram below will assist you finding the right code.



This means it is possible to have different codes for retail of textile depending on whether the response is

(i) Retail of textile in specialized store – 4751

or

(ii) Retail of textile, clothing and foot wear in stalls and markets – 4782

or

(iii) Hawking (other retail sale not in stores, stalls and market) textiles along the streets or in front of a house -- 4799

The address of the establishment will assist greatly in deciding on the appropriate code.

e) Note that at the market place, different economic activities are carried out for example cloth selling, food selling, dressmaking/tailoring/embroidery, corn milling, chop bar activities, hairdressing/barbering, etc. You must specify the actual economic activity of the respondent in the market. **Do not record vague terms e.g. "market activities, trading activities, selling activities, etc."**

Construction

Construction is another area where more detail is required. Construction is in Section F and classified into 3 divisions 41 - 43. These are further sub-divided into the following groups and classes.

Transport and Storage Section H

This is another section where more detail is required. Recording "transport service" or "storage facility" is not enough for coding this industrial activity.

Transportation is first classified by mode of transport, i.e., land, air and water. Each of these is further classified into passenger, freight and other transport as follows:
